of serving in two back-to-back Financial Squadron Commander positions, including as Comptroller or Chief Financial Officer of a military base with a budget in excess of \$169 million.

Her contributions to women in the military led to her receiving the Major T. H. Baca Award, named in honor of the first woman to officially serve as a commissioned officer in the National Guard, United States Army and military force, eventually rising to major and later appointed Assistant Adjutant General of New Mexico.



Karen is also a woman in philanthropy, continuing to honor the Air Force's second core value: "Service before Self." She supports a number of Tampa Bay organizations including MADD, Dress for Success, Bay Area Legal Services, ARCS and PACE. Other civic involvement includes being a WEDU Community Action Board member, the scholarship committee for Tampa Bay Business & Professional Women (BPW), supporter of Charity Chics, and member of e-Women Network, the ARCS Foundation and the NEW.

Surviving personal tragedy caused by a drunk driver led Karen to found the Traumatic Brain Injury Survivors Grant Fund Inc., a Florida non-profit corporation. The grant fund educates individuals about the uniqueness of each traumatic brain injury, increases awareness of this type of injury in our community and provides assistance and support to TBI survivors.

Karen has a Bachelor's Degree in Mathematics from Boston University, a Master's of Science in Business Administration and a second Master's of Science in Cost Estimating and Analysis from the prestigious Air Force Institute of Technology.
