artists helps sustain them in their profession.

Although the collection began in the late 1950s with predominately American artists, primarily from Florida, it has grown to include a variety of genres. In the mid 1980s, while on trips to Colorado and New Mexico, Mr. James began collecting Western and Southwestern art. Currently, more than half of the collection consists of Western/Southwestern styles, including works by Roy Andersen, Earl Biss, Glenna Goodacre, Allan Houser, Dave McGary, Dan Namingha, and Ray Swanson. Wildlife art makes up about 25% of the collection, with works by Matthew Hillier, John Seerey-Lester, Al Agnew, and Trevor Swanson. Other genres include Pop, Contemporary, Figurative, Sports Art, and Landscapes.

The James family, as well as Raymond James Financial, has long been a supporter of the arts. Raymond James Financial is the title sponsor for the renowned Raymond James Gasparilla Festival of Arts. In addition, Mr. James is currently president of the Salvador Dali Museum Board of Trustees.

Tours will begin at 11 am consist for groups of 6-8. Since the collection is so large, your group will get to select the type of art you would like to see. We'll begin our lunch and meeting at noon, and resume tours again at 1 pm. Tours last approximately 20-25 minutes.

Directions to Raymond James: Our event will be in Tower 4, rooms 7-14. Take Howard Franklin Bridge to the Ulmerton Exit 31. After exiting, turn left at Carrillon Parkway, and park in front of the first Raymond James Building. After entering Tower 4, stop at the reception desk to obtain a security badge before heading to room 7.


